Email Newsletter Trivia Contest

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Campaign is open only to those **18 years of age or older** as of the date of entry. The Campaign is only open to legal residents of **New York, New Jersey and Connecticut (The Tri-State Area)**, and is void where prohibited by law. Staff of **The Flatiron/23rd Street Partnership Business Improvement District dba Flatiron NoMad Partnership ("The Partnership")**, including all full & part-time Partnership staff, contracted vendors, or board members, (collectively "The Partnership Team"), and immediate family members and/or those living in the same household of "The Partnership Team" are not eligible to participate in the Campaign. The Campaign is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. You understand and agree that you are signing up to receive electronic communications via email from The Partnership and may unsubscribe at any time. In addition, You agree to accept the decisions of **The Partnership** as final and binding as it relates to the content of this Campaign.

3. Campaign Period: A total of five weekly giveaways will occur starting Wednesday, November 23, 2022 thru Wednesday, December 21, 2022. For each weekly giveaway, entries will be accepted via the email newsletter on Wednesday during the time period and ending **on the corresponding Friday at 12:00 pm EST**. All online and email entries each week must be received by **Friday at 12:00 pm EST**.

4. How to Enter: The Campaign must be entered by opening the Newsletter and clicking through to answer the trivia question via google form. You must provide all information requested to successfully enter. For an alternate method of entry, you may email the Flatiron NoMad Partnership at info@flatironnomad.nyc using the subject line “Holiday Cheer Trivia” including your name, email address and zip code. The entry must fulfill all Campaign requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of **The Partnership**. **Only 1 entry per person is allowed for each weekly trivia question.** You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of **The Partnership**.

5. Prizes: A total of 1 winner per weekly giveaway will receive digital gift cards or prizes up to \$200 in value. Actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by **The Partnership**. No cash or other prize substitution shall be permitted except at **The Partnership's** discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. Acceptance of prize constitutes permission for **The Partnership** to use Winner's name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within **30 days** from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. discretion, to maintain the integrity of the Campaign, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Campaign rules; or the use of bots, macros, scripts, or other technical means for entering.
