Onsite Enter to Win Contest

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This contest is open only to those who are 18 years of age or older as of the date of entry. The contest is only open to legal residents of New York, New Jersey and Connecticut (The Tri-State Area), and is void where prohibited by law. Staff of The Flatiron NoMad Partnership (“The Partnership”), including all including full & part-time Partnership staff, contracted vendors, or board members, (collectively “The Partnership Team”), and immediate family members and/or those living in the same household of “The Partnership Team” are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. You understand and agree that you are signing up to receive electronic communications via email from The Partnership and may unsubscribe at any time. In addition, You agree to accept the decisions of The Partnership as final and binding as it relates to the content of this Contest.

3. Contest Period: Entries will be accepted at the Flatiron NoMad Partnership tent starting on Wednesday, November 1, 2023 at 3 pm EST. All entries must be received by Wednesday, November 1, 2023 at 7 pm EST.

4. How to Enter: The Contest must be entered by filling out an entry blank at the Flatiron NoMad Partnership tent including full name, email address and phone number and placing it into the giveaway box. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of The Partnership. You may enter only once. You must

provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. The Partnership reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions. The Partnership has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering.
