Photo Challenge Giveaway

Follow @FlatironNY, post photo to Instagram Stories, tag @FlatironNY and use hashtag #DiadeMuertosWeek. Each Instagram Story capturing a challenge will serve as a unique entry. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of The Partnership. You must provide the information requested. You may not enter more times than indicated by using identities, or devices in an attempt to circumvent the rules.
