

# DÍA DE MUERTOS WEEK 2024

## Photo Challenge Giveaway

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This contest is open only to those who are 18 years of age or older as of the date of entry. The contest is only open to legal residents of New York, New Jersey and Connecticut (The Tri-State Area), and is void where prohibited by law. Staff of The Flatiron NoMad Partnership (“The Partnership”), including all including full & part-time Partnership staff, contracted vendors, or board members, (collectively “The Partnership Team”), and immediate family members and/or those living in the same household of “The Partnership Team” are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of The Partnership as final and binding as it relates to the content of this Contest.

3. Contest Period: Entries will be accepted via Instagram starting Monday, October 28, 2024 thru Saturday, November 2, 2024.

4. How to Enter: The Contest must follow the instructions based on the Día de Muertos Photo Challenge Post to be posted on the @FlatironNY Instagram on Monday, October 28, 2024. To enter, capture a photo of one of the listed photo challenge tasks in celebration of Día de Muertos Week in Flatiron & NoMad. Follow @FlatironNY, post photo to Instagram Stories, tag

@FlatironNY and use hashtag #DiadeMuertosWeek. Each Instagram Story capturing a challenge will serve as a unique entry. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of The Partnership. You must provide the information requested. You may not enter more times than indicated by using identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of The Partnership.

If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited

The Partnership has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering.
