

E-WASTE CYCLING DAY

Shack Party Giveaway

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This contest is open only to those who are 18 years of age or older as of the date of entry. The contest is only open to legal residents of New York, New Jersey and Connecticut (The Tri-State Area), and is void where prohibited by law. Staff of The Flatiron NoMad Partnership (“The Partnership”), including all including full & part-time Partnership staff, contracted vendors, or board members, (collectively “The Partnership Team”), and immediate family members and/or those living in the same household of “The Partnership Team” are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of The Partnership as final and binding as it relates to the content of this Contest.

3. Contest Period: Participants will be evaluated on Wednesday, April 16, 2025 during the ‘E-Waste Cycling Day’ event, hosted by the Flatiron NoMad Partnership and LES Ecology Center. This will take place on Flatiron South Plaza in New York City.

4. How to Enter: Contestants must follow the instructions provided by the Partnership on their ‘Spring in Flatiron & NoMad’ page. To enter, participants must provide their donation of e-waste cycling during the ‘E-Waste Cycling Day’ event. This includes: working & non-working

computers, monitors, printers/scanners, keyboards, mice, cables, TVs, VCRs & DVD players, phones, audio/visual equipment, cell phones & PDAs. The Contestant with the highest total volume of e-waste will win the grand prize. All entries must meet the specified requirements to be eligible for a prize. Entries that are incomplete or do not comply with the rules may be disqualified at the sole discretion of The Partnership. Participants must provide all requested information. Attempts to enter multiple times using different identities or devices to circumvent the rules will result in disqualification. Any fraudulent methods or attempts to bypass the rules may result in the removal of the submission from eligibility, at the sole discretion of The Partnership.

5. Prizes: One (1) winner will receive the grand prize: a free catered party for up to (20) individuals and up to \$500 provided by Shake Shack – Madison Square Park. This package includes a burger, sandwich, fries and non-alcoholic beverage per person. The winner will be able to either host their Shack Party at Shake Shack – Madison Square Park or coordinate a takeout catering order from the Madison Square Park location. The actual/appraised value may differ at time of prize award. The specifics of the prize shall be solely determined by The Partnership. No cash or other prize substitution shall be permitted, except at The Partnership's discretion. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by Winner is permitted. By accepting the prize, the winner grants The Partnership permission to use their name, likeness, and entry for advertising and promotional purposes without additional compensation, unless prohibited by law.

6. Odds: The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification: Winner will be selected by a random drawing under the supervision of The Partnership. Winner will be notified by email within five (5) days following selection of Winner. The Partnership shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 30 days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner may be selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. ANY VIOLATION OF THESE OFFICIAL RULES BY WINNER (AT THE PARTNERSHIP'S SOLE DISCRETION) WILL RESULT IN WINNER'S DISQUALIFICATION AS WINNER OF THE CONTEST, AND ALL PRIVILEGES AS WINNER WILL BE IMMEDIATELY TERMINATED.

Terms & Conditions: The Partnership reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond The Partnership's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. In such case, The Partnership may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by The Partnership. The Partnership reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Contest or website or violates these Terms & Conditions. The Partnership has the right, in its sole discretion, to maintain the integrity of the Contest, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Contest rules; or the use of bots, macros, scripts, or other technical means for entering. Any attempt by an entrant to deliberately

damage any website or undermine the legitimate operation of the Contest may be a violation of criminal and civil laws. Should such attempt be made, The Partnership reserves the right to seek damages to the fullest extent permitted by law.

Limitation of Liability: By entering, You agree to release and hold harmless The Partnership and its subsidiaries, affiliates, advertising and promotion agencies, partners, representatives, agents, successors, assigns, employees, officers, and directors from any liability, illness, injury, death, loss, litigation, claim, or damage that may occur, directly or indirectly, whether caused by negligence or not, from: (i) such entrant's participation in the Contest and/or his/her acceptance, possession, use, or misuse of any prize or any portion thereof; (ii) technical failures of any kind, including but not limited to the malfunction of any computer, cable, network, hardware, or software, or other mechanical equipment; (iii) the unavailability or inaccessibility of any transmissions, telephone, or Internet service; (iv) unauthorized human intervention in any part of the entry process or the Promotion; (v) electronic or human error in the administration of the Promotion or the processing of entries.

10. Disputes: THIS CONTEST IS GOVERNED BY THE LAWS OF THE UNITED STATES OF AMERICA AND NEW YORK STATE, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. Further, in any such dispute, under no circumstances shall participant be permitted to obtain awards for, and hereby waives all rights to, punitive, incidental, or consequential damages, including reasonable attorney's fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Contest). Participant further waives all rights to have damages multiplied or increased.
